CHC Athletics	Creates culture for campus. Budget impacts GF and will produce FTES. Ralph R. and Heather C. are creating an Athletics Plan. The funding has been requested as a part of PPR. Denise commented that College committed back before the pool was installed, and should have offset costs for future athletics programs. Partnership in tennis courts with City is ongoing. Strong programs at Redlands for "elite" sports. The fields that Yucaipa built is for college women's softball.	
	Ben M. commented eligibility is done by A&R to ensure compliance in gpa etc. Dave Rubio does this for SBVC and CHC will need a trained evaluator. Counseling will need dedicated athletics counselor. Developmental Budget Update & Enrollment Management Plan	Overcap funding: May revise is proposed to be 2.5% growth rate. We have 2.5 funding makes SBCCD the third highest funded in the state for growth. 2nd highest is Chaffey, we are third at 5.34%. San Jacinto is 7.6%. FTES is climbing by our college growth plan, targets are higher than growth plan. We can match district projections by adjusting summer. Enrollment Management FTES handout. If growth continues (see handout) Crafton's funded rate could grow to 9.11% and we will be the fasting growing college in the state. There is talk about one time increases to the block grant. Possible increase in base rate funding. Cola is projected 0.85%. Our budget for next year is bare bones, and has no discretionary funds at this point.
