1. Approval of Minutes from April 8, 2019 meeting

2. **COURSE MODIFICATIONS**

A. CIS 111 Web Page Programming and Design

The committee approved CIS 111 as a six-year revision.

- New Course Title: Website Design and Development I
- **New Catalog Description:** Introduction to website design for personal users, business users, and computer professionals. Introduces website design, development, and administration using HTML, XHTML, CSS, and scripting languages. Students will design, create, publish, and maintain web pages.
- New Schedule Description: Introduction to website design, development, and administration using HTML, XHTML, CSS, and scripting languages.

Note: The course will equate with CIT 122 at SBVC.

B. CIS 117 Scripting

The committee approved CIS 117 as a six-year revision. The DE component was put on hold until the course is approved by the ETC Committee. Gwen will contact Brandi Bailes, Co-Chair of ETC Committee, and Frank Madrid, CIS Instructor, to inform them of the process. Apparently, there was a glitch in CurricUNET that allowed the course to move through the approval process without approval from the ETC Committee.

- New Course Title: Web Page Scripting
- New Catalog Description: Introduction to web page scripting using current scripting languages; such as, JavaScript, Python, and PHP. Includes program development, debugging, and implementation of programs to enhance web pages. Course topics include Client side and Server side scripts, ASP and database integration.
- **New Schedule Description:** Introduction to web page scripting and programming. Includes development, debugging, and implementation of client side and server side scripts to enhance web pages.

Note: Course is not currently equated with SBVC.

C. CIS 125 C#.NET Programming

The committee approved CIS 125 as a six-year revision.

- New Course Title: C#.NET Programming

- New Catalog Description: Introduction to object-oriented programming using the C# programming language and the .NET Framework where we will design and develop programs, and test console and Windows applications. Topics include the C# programming environment, control structures, functions, classes, arrays, streams, Windows forms, and event handling.
- **Schedule Description:** Introduction to object-oriented programming using the C# programming language and the .NET Framework where we will design and develop programs, and test console and Windows applications.
