2. Action Items

COURSE MODIFICATIONS

A. CIS 101 Introduction to Computer and Information Technology

Until recently CIS 101 and BUSAD 230 were cross listed. Since the minimum qualifications for the course is Computer Information Science, it did not make sense to offer the course in Business Administration. BUSAD 230 was approved as a deletion at the June 20, 2019 Board meeting. CIS 101 is being submitted to clean up all references of BUSAD 230 on the course outline of record and to approve the Distance Education component.

The committee approved CIS 101 with revisions. Also, the DE component was approved (hybrid and 100% online).

- **New Catalog Description:** Introduction to computer and information technology, including the history, terminology, computer hardware and software components, operation of computer systems, networking, ethics, security, examination of information systems and their role in business. Includes an overview and use of selected software including operating systems, word processors, spreadsheets, presentation applications, database management systems, and basic web design and programming. Discussion of the impact of computers in society and the workplace.
- **New Schedule Description:** Introduction to computer and information technology. Examination of information systems and their role in business. Includes an overview and the use of computer software including word processing, spreadsheets, presentation applications and databases.

Note: Course is also offered as CIT 101 at SBVC.

B. COUN 900 Essentials for Student Services

E. PTA 110 Introduction to Physical Therapy

The Crafton Hills College Physical Therapist Assistant Program must comply with the standards of the Committee on Accreditation in Physical Therapy Education (CAPTE) in order to be accredited, as well as standards specified by the Physical Therapy Board of California for licensure. This course is one in a series of courses leading to a Physical Therapist Assistant Associate of Science Degree and will help the student prepare to take the state board exam to obtain a Physical Therapist Assistant license required for employment as a Physical Therapist Assistant Practitioner. Currently this program is only being offered at Cerritos College.

The committee approved PTA 110 as a new course. Danny Rojas will update the Student Learning Outcomes.

- **Schedule Description:** Introduction to the history and ethics of physical therapy in the health care setting. Includes team dynamics, rehabilitation philosophy, treatment options, body mechanics, vital signs and terminology.

F. PTA 120 PTA Kinesiology

I. 3D Computer Animation Certificate

The certificate has been redesigned and is now a new certificate in the Multimedia discipline.

The committee approved the deletion of the 3D Computer Animation Certificate.
