- 2016-17 Replaced sewer ejector pit controls/pump; constructed high water alarm notification system
- PAC Theater ADA seating
- Scene shop dust collection system
- Replaced scissor lift
- Replaced the Stage Curtains (fire retardant)
- PAC dressing room renovation with ADA and finish

3. Measure M Safety Related Projects (Bond Approved in Nov. 2008)

- CNTL Renovation (included elevator replacement, lockdown, and access control)
- CTB Renovation (included elevator replacement, lockdown, access control, and security cameras)
- Replacement of OE2 with PSAH
- Canyon Hall replaced old science labs (improved safety with new fume hoods, cadaver room engineering controls, lab ventilation, improved chemical storage

• ADA path of travel and ADA parking improvements throughout campus
