Below are the nine expenditure categories that are permissible for use by the colleges, and which are reportable to the Chancellor's Office:

Below are five guidelines that might help you decide how to expend your basic skills allocation. Ultimately it is the college who must make the judgement; however, the Chancellor's Office can try to help with some guidelines when making a decision:

- 1. Colleges cannot use basic skills funding to support non-basic skills students.
- 2. Basic skills courses are pre-collegiate; as such, they are not degree-applicable or transfer courses.
- 3. So long as support activities such as tutoring are exclusively provided to students in non-degree applicable basic skills math or ESL courses, a college is within the intention of the legislation and is properly expending basic skills allocation funds.
- 4. If a basic skills student takes a non-basic skills course, basic skills funds can be used to support them in that course, in areas where the basic skills student is deficient. For example, if a student who has tested below college-matriculation level in reading takes a political science course, basic skills funds could be used to provide specific help with reading.

5. ESL courses can be classified as basic skills, or non-basic skills. An ESL course below degree and transfer level could be eligible for basic skills funding if it is not designated as degree applicable. An ESL course that is degree-applicable, or transferrable would not be eligible for basic skills funding.

AB 194, Committee on Budget. Budget Act of 2007.

The Budget Act of 2007 made appropriations for the support of state government for the 2007–08 fiscal year.

This bill would amend and supplement the Budget Act of 2007 by revising items of appropriation for the State Department of Health Care Services, the Employment Development Department, the Department of Parks and Recreation, the State Department of Education, and the Board of Governors of the California Community Colleges.

This bill would declare that it is to take effect immediately as an urgency statute

Of the funds appropriated by this act from the General Fund and special funds, other than the Off-Highway Vehicle Trust Fund and bond funds, to the Department of Parks and Recreation for local assistance grants to local agencies, the department may allocate an amount not to exceed 3.7 percent of each project's allocation, except to the extent otherwise restricted by law, to allow the department to administer its grants. Those

- funds shall be available for encumbrance or expenditure until June 30, 2013.
- 2. It is the intent of the Legislature that salaries, wages, operating expenses, and positions associated with implementing specific Department of Parks and Recreation capital outlay projects continue to be funded through capital outlay appropriations, and that these funds should also be reflected in the department's state operations budget in the Governor's Budget as a special item of expense reflecting the funding provided from the capital outlay appropriations.
- Notwithstanding any other provision of law, the Director of Finance may authorize a loan from the General Fund, in an amount not to exceed 35 percent of reimbursements appropriated in this item to the Department of Parks and Recreation, provided that:
  - (a) The loan is to meet cash needs resulting from the delay in receipt of reimbursements for services provided.
  - (b) The loan is for a short term and shall be repaid by September 30, 2008.
  - (c) Interest charges may be waived pursuant to subdivision (e) of Section 16314 of the Government Code.
  - (d) The Director of Finance may not approve the loan unless the approval is made in writing and filed with the Chairperson of the Joint Legislative Budget Committee and the chairpersons of the committees in each house of the Legislature that consider appropriations not later than 30 days prior to the effective date of the approval, or not sooner than whatever lesser time that the chairperson of the joint committee or his or her designee may determine.

Basic Skills

(A) Funds allocated pursuant to this paragraph shall be expended for program and curriculum planning and development, student assessment, advisement and counseling services, supplemental instruction and tutoring, articulation, instructional materials and equipment, and any other purpose directly related to the enhancement of basic skills, ESL instruction, and related student programs. The allocated funds shall supplement, and not supplant, current expenditures by districts for matriculation and assessment services, basic skills, ESL instruction, and related student programs.

(B) To be eligible to receive funds pursuant to this paragraph, a district must submit to the Office of the Chancellor an application containing a certification that the college will, within the fiscal year, (i) complete an assessment of its programs and activities serving basic skills and ESL students utilizing the assessment tool developed pursuant to paragraph (1) of Item 6870-493 of Section 2.00 of the Budget Act of 2006 (Chapters 47 and 48 of the Statutes of 2006), and (ii) submit to the Office of the Chancellor an action and expenditure plan for funds received under this

(C) The Office of the Chancellor shall work jointly with the Department of Finance and the Legislative Analyst to develop annual accountability measures for this program. It is the intent of the Legislature that annual performance accountability measures for this program utilize, to the extent possible, data available as part of the accountability system developed pursuant to Section 84754.5 of the Education Code. By November 1, 2008, the Chancellor shall submit a report to the Governor and Legislature on the annual accountability measures developed pursuant to this process.

(D) The Chancellor shall distribute funds to districts on the basis of the following two factors, with equal weight given to each: (i) the number of full-time equivalent students generated in basic skills and ESL courses in the preceding fiscal year; and (ii) the number of full-time equivalent students generated in basic skills and ESL courses by students transitioning from high schools in the preceding fiscal year. For purposes of distributing these funds, the Chancellor may establish a minimum allocation of one hundred thousand dollars (\$100,000) per college.

SEC. 10. This act is an urgency statute necessary for the immediate preservation of the public peace, health, or safety within the meaning of Article IV of the Constitution and shall go into immediate effect. The facts constituting the necessity are:

In order to ensure that state programs are properly funded for the 2007–08 fiscal year, it is necessary that this act take effect immediately.

I am reducing the \$749,000 augmentation for implementation of federal nental health parity laws by \$374,000 from the Department of Insurance's Consumer Protection program. The augmentation that remains in the Budget will allow the Department to monitor health insurers' compliance with mental health parity laws and other insurance laws.

<u>Item 2720-001-0044</u>—For support of Department of the California Highway Patrol. I reduce this item from \$1,857,048,000 to \$1,856,348,000 by reducing:

(1) 10-Traffic Management from \$1,796,503,000 to \$1,795,803,000.

I am reducing the \$700,000 augmentation for a teen driver education and safety study. Teen driver education and safety are a high priority for my Administration, and the Transportation Agency is already working with the California Highway Patrol and the Department of Motor Vehicles to develop a comprehensive teen driver education program. Therefore, this increase is unnecessary.

I am deleting Provision 3 to conform to this action.

<u>Item 3360-403-0033</u>—For support of Energy Resources Conservation and Development Commission. I delete this item.

I am deleting this item. It was erroneously included in the Budget Bill. Item 3360-403 already transfers \$28 million from the Job Creation Fund to the State Energy Conservation Assistance Account. This action conforms to legislative intent.

<u>Item 4150-001-0933</u>—For support of Department of Managed Health Care. I reduce this item from \$60,640,000 to \$58,538,000 by reducing:

(1) 30-Health Plan Program from \$64,127,000 to \$62,025,000.

I am reducing the \$4,204,000 augmentation for implementation of federal mental health parity laws by \$2,102,000. The \$2,102,000 augmentation that remains in the Budget will help the Department in reviewing health plans' compliance with the federal law consistent with the Department's implementation plan. In the coming year, my Administration, through the Department of Managed Health Care, will review health plan filings, and identify any areas of concern and any additional resources needed to address them. The Budget also includes an augmentation that was included in the May Revision for clinical and actuarial contracts that will further help with initial implementation.

By September 1, 2010, the chancellor shall submit a report to the Governor and the Legislature on basic skills accountability using system- and college-level data and an annual report each year thereafter by September 1.
- 10. (a) Of the funds appropriated in Schedule (6) for Student Financial Aid Administration, not less than \$15,363,000 is available to provide \$0.91 per unit reimbursement to community college districts for the provision of board of governors (BOG) fee waiver awards pursuant to paragraph (2) of subdivi-
