This course is for the EMT/NREMT practitioners as a refresher course every two years, or the EMT student that was unsuccessful three-times with the National Registry cognitive exam as a 24 hour refresher course. California Code of Regulations requires training agencies to offer one of these refresher courses each semester as long as an EMT certification course is being offered. Graded on a Pass / No Pass basis only.
