2.0 Professional Experience

Vice President, Instruction (2013-Present)

As VPI, Dr. Reece oversees the academic program at Crafton Hills College. Over 60 programs in academic and career technical areas report to him, including over 200 faculty members and 6,000 students. In addition to the instructional programs, academic service areas such as the library and tutorial services report to Dr. Reece. He is responsible for curriculum development, course schedule development, catalog development, and more. In this capacity, Dr. Reece reports directly to the College President.

Managing Editor, Mypoliscilab (2005-Present)

As managing editor and lead author, Dr. Reece manages two other co-authors and 4-5 contributing authors in the development of content. He manages/coordinates a technical team of 6-10 programmers, video production specialists and clerical assistants depending on the flow of work. He communicates with a faculty community/users group of approximately 1,000 political scientists. Over 100,000 students each year access Mypoliscilab as an online learning resource for their introduction to American Government course.

Dean of Academic Success and Institutional Effectiveness (2010-2013)

Dr. Reece was dean over the Student Success Division. The Division was developed through a college reorganization in 2010. As Dean, he launched the Success Center, revamped the Center for Teaching Excellence, launched the Assessment Office, managed media services for the entire campus; managed several services through the iFalcon Office; and maintained the Student Success Plan for Cerritos College. The Division provided academic support services to all 23,000 students and over 600 faculty members. Dr. Reece managed a staff of approximately 150 individuals from classified, hourly and faculty ranks.

Dean of Humanities and Social Science, Cerritos College (2009-2010)

At the time of Dr. Reece's deanship, the Humanities and Social Sciences Division was home to over a dozen academic departments including transfer and vocational programs. The Division faculty included approximately 80 fulltime and part-time members, teaching over 20,000 students each year. Over the fall, spring and summer terms, the Division offered between 500 and 600 sections. As Interim Dean, Dr. Reece led the Division with a team of three clerical staff members, eight student workers and seven faculty chairpersons. The Division operated with an annual budget of over \$5M.

President, Cerritos College Faculty Senate (2005-2009)

As the Cerritos College Faculty Senate President, Dr. Reece administered a specific set of responsibilities outlined by Cerritos Board Policy and California Ed Code. As President, Dr. Reece managed Senate proceedings, the Senate executive team, 30 senators, and 7 Senate committees (70-80 members combined). Dr. Reece coordinated with CSEA, CCFF, ACCME, ASCC, administration, and the Board of Trustees. In this capacity Dr. Reece has been an important leader on issues related to student learning, college management, infrastructure development, academic development and more.

Vice President, Civic Resource Group (1997-2002)

Civic Resource Group (CRG) develops technological solutions to meet the unique needs of civic organizations. They provide strategies, tools and solutions that empower organizations and businesses operating in the civic sector. They help civic organizations operate more efficiently, communicate more effectively, and connect with their communities by helping organizations manage the process of integrating new information technology and leveraging their organizational assets to realize the full potential of new technologies. As vice President, Dr. Reece provided consulting services on communications and business practices to several public organizations. A sample of clients includes: Metropolitan Water District, City of Murrieta, City of Poway, Lane County, City of Diamond Bar, UC Riverside, and Mt. San Jacinto College.

Director of Education Development (2002-2005)

Under the direction of John Grindel (former Cerritos College President), Dr. Reece represented the College in several developmental capacities. In this position he led the organization of an earmark campaign for the College and developed several partnerships with local, state and federal agencies in an attempt to broaden the College's educational opportunities.

Professor, Political Science Department, Cerritos College (1991-2009)

Dr. Reece taught fulltime in the Political Science Department for fourteen years. During that time, he taught over 10,000 students, from nearly all 50 states and several other countries. Courses taught included Introduction to American Politics, Introduction to Political Theory, Introduction to Political Science, Political Economy, California, State and Local Politics, Direct Studies Seminars on Technology and Government, Internet Strategies for Government Institutions, Campaigns and Elections, and Law and Public Policy. Dr. Reece has taught in traditional and online environments. He has received numerous awards for excellence in teaching including: Cerritos College Outstanding Faculty Member (2009), California Educator of the Year, California Community College Association for Occupational Education (2003) and Cerritos College Outstanding Faculty Member (2002).

3.0 Academic Leadership (Partial List)

- Cerritos College Student Success Plan (2009-present). In February of 2009, the Board of Trustees called for the development of a College wide student success plan. Dr. Reece is chairing the taskforce to develop and implement this plan. The plan was approved by the Board of Trustees in December 2009. Dr. Reece is leading the implementation of the plan.

- iFALCON Campaign (2006-present). Dr. Reece led in the development and launch of the iFALCON Campaign, a campaign to teach students the habits of mind practiced by successful students. In 2009, the iFALCON program was awarded a 5-year, \$2.8 million Title V grant.
- Celebration of Student Success (2006-present). In coordination with the Academic Affairs Committee and the iFALCON Management Team, Dr. Reece moved the Academic Excellence Awards ceremony under the shared governance structure and helped expand the celebration of student success in the ceremony and across campus.
- Transfer Push (2008-present). In 2008, Dr. Reece led the development and launch of the Transfer Push program. The program brings all faculty into the recruitment process, through a basic campaign to identify eligible transfer students and encourage them to apply for transfer, attend transfer workshops, and more.
- Developmental Education Plan (2006-present). As co-chair of the Basic Skill Committee in 2006 and 2007, Dr. Reece helped prepare the College for participation in the state wide Basic Skills Initiative. Dr. Reece helped transition the ad hoc committee into a shared governance committee (now known as the Developmental Education Committee) and continues to play a role in developing and implementing a coordinated approach to developmental education.
- Program Review (2007-present). In coordination with the Program Review Committee, Dr. Reece has helped expand and enhance instructional program review. He has also been a leading advocate for the development of a collaborative approach between instructional program review and non-instructional program review. He has also been instrumental in securing a more meaningful relationship between Program and Review and the overall College planning process.
- SLO Plan (2008-present). Dr. Reece led in the establishment of the SLO shared governance committee. As the Committee's initial chair, Dr. Reece helped revise and develop a comprehensive SLO plan for the campus. The plan has been well received by the faculty and positioned the College ideally to respond to recommendations from the accreditation team.
- Agenda for Student Success (2006-present). Under the leadership of Dr. Reece, the Senate worked on an ambitious student success agenda (the Agenda for Student Success). The Agenda continued to grown for several years. It was instrumental in shifting the focus of the Senate to academic matters and had a similar impact across campus.
- State of Education Address (2007-present). In 2007, Dr. Reece organized the first state of education address for Cerritos College. The address provided an overview of the College's academic program and provided recommendations on how to proceed to improve the academic program. The address continues as a College program.
- Emergency and Part-Time Hiring Standards (2006-2009). In conjunction with the Hiring Standard Committee, Dr. Reece led the overhaul of Cerritos College's emergency and part-time hiring standards. The overhaul brought the College into compliance with State standards and requirements.
- Co-chair, Education Technology Accreditation Committee (2007-2008). As co-chair, Dr. Reece helped prepare the education technology section for the accreditation visit.
- Author and Program Developer, E-Book Publications (2002-2004). The E-Book Publications program was a Cerritos College initiative that developed and published interactive texts for use in core College course. Dr. Reece helped expand the program.
- Lead Developer and Program Manager, Tribal Technology Training Program (2002-2004). TribeTech was an education program initially funded through a grant by the Verizon Foundation. Developed in partnership with HUD's Office of Native American Programs, TribeTech focused on technology training for tribal/native American government professionals.

The fee will offset technology related costs and should generate about \$200,000 annually through student fees. Dr. Reece helped with the research on this fee and was instrumental in moving the proposal through the decision-making process at the College.
- Title V Grant (2009-2014). Cerritos College was awarded a Title V grant in 2009 for \$2.8 million. The grant funds further develop of the iFALCON campaign—a student engagement initiative developed by Dr. Reece. Dr. Reece was instrumental in organizing the grant writing effort and now is the lead administrator on the iFALCON/Title V management team. The grant period last through 2014.
- Legislative Earmarks and Set-asides (2001-2004). Prior to Professor Reece's leadership, Cerritos College had not historically pursued federal or state earmark funding. In legislative year 2002, Professor Reece led the College's first venture into this funding arena. The program has now been institutionalized at Cerritos College. In 2009, the College realized its first round of federal government earmarks.
- E-Book Program (2001-2004). Cerritos College started an in-house publishing program in 2001 to assist faculty with the development of e-books. Under this program, Professor Reece helped develop the most successful e-book at the College, extending beyond the local college market and into a national arena in a publishing agreement with McGraw-Hill. The development was very profitable to the College.
- Co-Investigator and Principal Grant Writer, Research Paper Pathway Project, \$87,000 (2007). The grant funded the development of an online research paper resource for Cerritos College faculty and students.
- Project Manager, Government Technology Training Program funded by VTEA, \$80,000 (2004). This grant was awarded to the Political Science and CIS departments at Cerritos College.
