PARTICIPATION BY STUDENT LEADERS IN GOVERNANCE 2009/2010

Overview: The 2008 Accreditation Evaluation Report recommended that "The college should...establish more widespread participation by...students" in the college's governance structures and processes, such as shared governance committees. As a result, Crafton Hills College (CHC) Student Leaders have been asked to participate in shared-governance, advisory, steering, or planning committees, councils, or other governance groups during the 2009-2010 academic year both at the College and District.

Methodology: In an effort to obtain feedback from CHC Student Leaders regarding their experiences as representatives in shared-governance groups, a paper survey was administered during a regularly scheduled Associated Students meeting. The survey included one multiple choice question asking participants to select the number of governance groups they had personally served on at any time in the 2009-2010 academic year. Following were four questions using a four-point likert scale with choices ranging from *Strongly Agree* to *Strongly Disagree*. These questions asked students to rate their personal experiences while participating on a shared-governance body. In addition, there were five questions using a four-point likert scale with choices ranging from *Strongly Agree* to *Strongly Disagree* asking students to rate their level of agreement with statements about the CHC Student Senate's overall participation in shared-governance. Finally, there was one open ended question requesting additional suggestions and comments about student participation in governance.

Sample: Ten respondents chose to participate in the Student Leaders in Governance Survey at the Associated Students meeting on April 26, 2010.

RESULTS

Findings: CHC Students Leaders served on a variety of shared-governance, advisory, steering, or planning committees, councils, or other governance groups during the 2009-2010 academic year. Specifically, in Table 1, 90% of the respondents indicated that they had served as a student representative for one or more Crafton or District shared-governance body.

Table 2 illustrates that 100% of the respondents *Agreed* or *Strongly Agreed* with all of the statements concerning their overall participation in the governance group(s) on which they served. Moreover, 67% of the respondents strongly agreed that they felt comfortable contributing ideas and that they learned a lot about how things work at the College and District.

Student leader's thoughts about their participation in Student Senate discussions and actions regarding important issues facing the college can be seen in Table 3. One hundred percent of respondents agreed or strongly agreed with all of the statements related to the Student Senate's overall participation in College governance during the 2009-2010 academic year. For instance, the majority of respondents (89%) strongly agreed that the CHC Student Senate has had sufficient opportunities to provide input on important issues facing the College.

When respondents were asked to provide additional suggestions and comments about the student participation in governance at Crafton Hills College or at the District level, one respondent chose to do so, proposing the following suggestion;

Provide a rubric of all the committees on campus and at the District at the beginning of fall semester so we can place students on the committees as soon as possible.
