Institutional Assessment Plan & Outcomes update for Academic Senate Feb 15 th . Status report, Gary Williams	Gary shared the PointPoint he gave to the academic Senate concerning the IAP. Last week was the 1 st reading; next meeting will be consideration for approval. Idea: Program Review is may function as a collection point for SLO progress. CCBC Website and reporting	Keith shared a website from a presentation he attended at the RP Group Conference by the Community College of Baltimore. Four levels of report and linages to them were provided: Course, Program, General Education, and ILO Assessment Reports. The site used a simple reporting template that aligns well with our 5-step process. ILO Assessment and discussion of results (Keith), any further information or comments?	As recommended by the committee, Keith re-ran the CCSSE diversity data for students who have ocmpleted 30 units or more. There was no substantial or statistical difference from those who were enrolled in capstone courses. 75% of CHC students who completed 30 or more units felt that their experience at CHC contributed to their ability to understand people of other racial and ethnic backgrounds; and how to contribute to the community.	
April 3 rd Planning (In-Service)	There was discussion about ensuring participants they can finish their assessments at this in-service event. The title may be changed to be more compelling. It is important to recognize good work and share new assessment ideas.	Further planning will take place at the next meeting.
