This Month's Topic: Planning and Program Review

This volume focuses on discussing the planning and program review (PPR) process at Crafton Hills College. This Did You Know will cover what Planning and Program Review is, why it is important, and links to additional information regarding the Planning and Program Review process.

What is Planning and Program Review?

Planning and program review refers to the process by which departments and areas of the college (Instruction, Student Services, Administrative Services, and the President's Area) reflect on their mission, long term goals, and evidence gathered in support of their mission/goals. The process also serves as a vehicle by which departments/program units can request and secure additional resources to better meet their mission and goals. In this way, the program review process is designed to help departments and program units enhance what they do for students and the college.


The planning and program review document asks each area to discuss the following:

- The mission of each unit and how it aligns with the college's mission
- Description of program and whom you serve (student service areas) or any activities provided outside of instruction (for instructional programs)
- External factors that have a significant impact on program
- Summarizing outcome data and discuss what improvements could be made based on the results of the outcomes data
- Unit's performance on institutional quantitative effectiveness indicators
- Evaluation of area what is going well or not going well and why
- Vision for the area and where you would like the program to be four years from now
- Progress on goals set in previous PPR documents
- The setting of a four-year Action Plan (setting of goals, objectives, resource requests, and activities)

Why is Planning and Program Review Important?

The PPR process allows each area to reflect on their success, areas for improvement, goals moving forward, and the resources needed to operate more efficiently. When these documents are submitted and reviewed by the PPR committee, they are used in order to inform the construction of a roll-up plan for each area. These plans are then reviewed by the PPR committee and which inform the objectives and resource requests that the college prioritizes as shown by the diagram below:

These prioritized objectives are then communicated out to the campus and inform how resources are allocated to the different areas on campus. By participating in this process, each area has the opportunity to make their needs known and to assess how they are progressing on the goals set in previous PPRs going forward.

- Exemplary Program Reviews: These are program reviews done by different areas in previous years that were identified to be great examples to emulate.
