7. Faculty roles and involvement in accreditation processes.
8. Policies for faculty professional development activities.
9. Processes for program review.
10. Processes for institutional planning and budget development.
11. Other academic and professional matters as mutually agreed upon.

Consult Collegially means that the district governing board shall develop policies on academic and professional matters through either or both of the following:

- Rely primarily upon the advice and judgment of the academic senate, OR

The governing board, or its designees, and the academic senate shall reach mutual agreement by written resolution, regulation, or policy of the governing board effectuating such recommendations.

BIT Presentation (Evan)	Information about the Behavior Intervention Team that is forming. Idea is to support students before things become a major issue or incident. Have a webpage. Open to suggestions for changes. Form is not for academic conduct issues. Any issues with HIPPA or FERPA? Both have an exception for health and safety exception. An awareness of potential harm must be addressed. Some issues with confidentiality – Health and Safety codes are clear about who can be notified in the event of a concern – the college is not one of them. There are encryption standards with HIPPA and FERPA that we may not meet. Great program, but we need to make sure we are protecting student information. Need to contact IT about internet security. Will this be incorporated with Starfish? Yes, in some way. There are national models available. We should strive to be as close to the national models as possible.
