III. Coding for CCAP students

Sponsor: Larry Aycock

- CCAP Colleage Carrier Access Pathway, a dual enrollment agreement with high schools. Allows us to offer remedial courses to high school students, and collect FTES for it.
- There are some CCAP agreements with Redlands and Yucaipa schools.
- Thinking about code CCAP students separately, in XSTM3.
- Time Stamp 1:09:02, April expressed some concerns regarding CCAP at Valley and fees.

- Valley is wondering if CCAP should be treated as sponsorship? or how they should be billed the fees.
- CCAP at Velley are coded as high school students. Enrollment fees are waived, but fees are not. April thinks the fees should be waived as well.
- Larry suggest to refer to the MOU with the high school.
- Andy suggest that if they want to bill them differently, then they should be coded differently.
- Brock received a helpdesk ticket about creating CCAP codes to XSTM3.
- L4LCCAP Learn4Life CCAP Students, PALCCAP PAL Charter CCAP Students
- RCCAP RUSD CCAP Students, SBCCAP SBCUSD CCAP Students
- Larry thinks these codes are too specific to one school, he thinks it's better to have one partnership code, then identify them based on what courses they are in.
- April has some concerns regarding that (Time stamp 01:15:20)
- Christopher brings up a point on depending on how this is coded, can affect 320 reporting (Time stamp-01:15:55), unless he is made aware of new partnerships, if the CCAP students are not all coded under one code, it may affect the 320 reporting.
- Larry asked April to follow up with Patty Quach's group to discuss this further and submit a ticket for code updates.
