She shared some of the history and findings that have limited hiring practices. We now have a pilot process that has been used for hiring VPAS at Valley. This is being piloted with management positions before rolling out to all positions. The process is focused on eliminating arbitrary barriers to expand candidate pools.</li> <li>Q&amp;A – Identifying details are removed prior to interviews, candidates are known to hiring committee with first names only; Q - Will there be data following candidates that have been hired through this process? A – Once they are hired, they will be evaluated the same way as everyone else. Eval process will also be updated.; Q – Who chooses the subject matter experts?
