Crafton Council Sub- Committee Chart – Brandi, Gio and Cyndie	The draft chart shows only those sub-committees that report to Crafton Council and a separate page for each month for Fall semester. Each committee is color coded and noted on the month chart for a visual to see when the committees meet. Only one committee overlapped another but they only meet quarterly. The list below the chart shows the committee membership as reflected in their charge and the names of the committee members as reported by the Senates. This is a work in progress. Gio will be working on another piece to the information which will show the percentage makeup of each constituency group for each committee. It was discussed about the best times for committees to meet. It was agreed that afternoons work best. Kevin said he will work with Gio and Cyndie to look at this more in depth. Committee Self- Evaluation Review- Gio	Gio went over the survey results from last May for all the committees. Instead of a pdf document, they have created a dashboard with drop down menus. You can look at all the committees combined or select specific committees to get to the information.	
	Gio indicated that we need to peak interest across the campus to get participation on committees. One issue is finding time to get away from work schedules to participate on committees. It was suggested that we do a separate survey campus wide to increase participation. However, after discussion it was determined that these types of questions were included in the last Climate survey. Classified staff and non-instructional faculty members need active encouragement from managers to participate so workloads can be covered to allow them to attend committee meetings.	
	Another item discussed was if members on committees understood their role to report information to their constituency group and also to bring questions or issues from their constituency group back to the committee. Gio and Brandi will be including this in the planned committee training they are working on.	
	Madeleine suggested scheduling committees that need attendance at the most convenient times and putting committees where people do attend at less desirable times.	

Committee Self- Evaluation Review- Gio	We have approximately 200 full time or permanent employees and less than 50% participation in committees. We need a goal to increase participation. Gio suggested a quarterly newsletter sent to the college to highlight accomplishments from the shared governance committees. Crafton Council would need to request the information from the committees that report to them. Brandi indicated it should be printed as well as emailed to everyone. Keith and Gio will work on this.
