Review and approve minutes for October 11, 2022	The minutes for 10-11-22 were approved as written. Motion for approval of minutes made by Brandi, seconded by Meridyth McLaren. No opposition. No abstentions. Motion approved.	
PPR Finalization — President's Cabinet Response - Gio	At the end of every academic year the PPR committee and the President's Cabinet gets together to reflect on changes and makes request or recommendations. Documents to be shared: Memorandum and 2021-2022 One-Time PPR Resource Requests-Funded Items. These documents will be shared with the Crafton Council members and then sent to the entire campus. Members were given copies of both documents. Suggestions and feedback by members: -Calling mask "theater mask" -Members have been told in the past if you want or need anything else, to put it in the PPR. Kevin states there needs to be discussions in all areas of what is ongoing or one time fund. If it needs maintenance it needs to go into their developmental budget. In the past they had to place the items in each year to get the items. PPR committee is working on item request process. Items specifically costing less than \$500 do not need to be placed in the PPR. Need to have more conversations of what the process looks like. It could end up having a lot of items in the departmental budgets. Members stated that they have been told repeatedly that if it is not in your department PPR then you can't get the items.

PPR Finalization --Need to move personnel out of it completely. PPR does not President's Cabinet apply to faculty positions. Need to have another process for Response (continued) faculty. -There are items that are older and continue to roll over, but not being used. Safety issues have been placed in the PPRs and are not being funded. -Would like budget committee to be involved with PPR committee and work together. -Members asked about the Campaign Feasibility Study and the \$48,000 allocated amount. It is a study that is required to do before doing a large campaign. Foundation needs this one-time investment funds from auction sales. All the funds raised go directly into the college to support students. Campaign Feasibility study \$48, 0000. Definition of Membership -What do the membership lists mean? -Discussion was to have more classified staff to participate. - Brandi Adding more seats so anyone can join doesn't seem like a solution. -Would like to have the membership conversations again with the subgroup. Maybe wording "up to" or "at least". How do we create an environment that is inclusive of all? Subcommittee level and top levels have two different definitions of what the membership lists are. A uniform approach is what is being sought. -Having two different definitions causes barriers, it makes it less transparent coming in. Does it create an equal vote? Specially must list "at least" to allow more people to join. -Share with chair committees that the membership lists are broader now. -Keith suggested drafting a committee draft that goes out to all committees, Diana can work on this. Classified members and students want to become members but can be difficult when those members do not attend. Brandi is suggesting we standardize our membership language with the governance committee. -One solution could be having an equal number of amongst the constituencies. -No action taken today. Next meeting, Gio and Kevin are
