Campus Climate Survey - Gio	<p>This is an employee survey for Crafton only that hasn't been used for several years. IERP reviewed the survey and presented a reduced number of questions due to redundancy. We had two open forums and took to all the senates for review. It was approved by IEAOC. Bringing it to Crafton Council for final approval.</p> <p>Gio indicated that a handful of items are specifically tied to the Educational Master Plan especially regarding shared governance. This gives us a solution to augment our project budgets.
