

1 **Procedure for Establishing and Modifying Course Caps**

4 **I. Definitions**

- 5 A. Course Caps mean the maximum number of student that can be enrolled in a course,
6 as listed on the Course Outline of Record.
7 B. Section caps are the total number of students that can enroll in a section of a course.
8 Section caps for individual sections of a course may be less than the course cap due to
9 factors such as site restrictions, classroom size, and/or modality.

11 **II. Principles for the Initial Establishment and for Modification of Course Caps**

- 12 A. Course caps should be based on sound pedagogical principles
13 B. Initial course caps will be established by September 30, 2014. This will occur through
14 consensus of the discipline faculty, department chair, and vice president of instruction.
15 Beginning October 1, 2014 these agreed upon (initial) course caps for all courses will
16 be listed on the Course Outline of Record (COR) for each course.
17 C. Faculty members have the authority to submit a course revision to the Curriculum
18 Committee to modify the existing course cap based on the criteria outlined in section IV
19 below with appropriate documentation.
20 D. After the Curriculum Committee approves a course revision to modify a course cap, the
21 new course cap will become the official cap for student enrollment for that course and
22 will be listed as such on the Course Outline of Record (COR), effective the following
23 semester after approval.

25 **III. Process for Changing Existing Course Caps**

- 26 A. Discipline faculty may submit a course revision to the Curriculum Committee to modify
27 an existing course cap based on the established criteria as outlined in section IV below,
28 each of which must be supported and/or justified with appropriate documentation. One
29 criterion is required, but two or more are recommended for justification of a Course
30 Cap modification proposal to the Curriculum Committee.
31 B. Documentation to support a proposal to change a course cap based on one or more of
32 the criteria listed in part IV may include, but is not limited to, the following:
33 1. Comparative research of caps for similar courses at other California
34 community colleges;
35 2. Recommendations or requirements from a professional or academic
36 publication or organization; and/or
37 3. Course specific documentation, such as course syllabus, assignment criteria,
38 SLOs, and objectives.
39 C. Proposals to change the existing course cap for a given course will be reviewed by the
40 Curriculum Committee. The committee will determine whether or not the proposed
41 change and supporting documentation are consistent with the established criteria for
42 the modification of a course cap and will make the final decision regarding the proposal
43 to change the existing enrollment cap for a course.

45 **IV. Criteria for the Modification of Course Caps**

46 Modifications to a course cap must be justified with at least one of the below criteria, and it is
47 recommended that two or more criteria be considered in a proposal to modify a course cap.
48 Under each criterion below, suggested examples are provided of the types of data that may be
49 used to justify a modification to a course cap. In addition, faculty members who propose a new
50 course to the Curriculum Committee can opt to establish the course cap based on the course
51 cap of a similar course(s) within the discipline or based on one or more of the below criteria:

Modifications to a course cap must be justified with at least one of the below criteria, and it is recommended that two or more criteria be considered in a proposal to modify a course cap. Under each criterion below, suggested examples are provided of the types of data that may be used to justify a modification to a course cap. In addition, faculty members who propose a new course to the Curriculum Committee can opt to establish the course cap based on the course cap of a similar course(s) within the discipline or based on one or more of the below criteria:

- A. Course Modality
 - Lab courses vs. combined lecture and lab courses – course caps may be determined separately for labs, which may have different limitations compared to lecture-only courses.
- B. Instructional Delivery
 - Nature of classroom activities
 - Nature of interaction between instructor and students
 - Use of group work or group projects
- C. Student Assessment
 - Types and/or amount of individual assignments, projects, and/or papers to assess
 - Methods of student assessment, feedback, or evaluation
 - Course-level or Program-level Student Learning Outcomes
 - Course objectives in the COR
- D. Use of Existing Course Cap for a similar course(s) within the discipline
 - For new courses only - cannot be used as one of the required criteria for modifying an existing course cap
 - New course should be comparable (i.e. objectives, topics and scope, assignment, assessment, and pedagogy) to other course(s) in the discipline
