- a. Provide text alternatives for non-text content.
- b. Provide captions and other alternatives for multimedia.
- c. Create content that can be presented in different ways, including by assistive technologies, without losing meaning, thus making it easier for users to see and hear content.

2. Operable

- a. Make all functionality available from a keyboard.
- b. Give users enough time to read and use content.
- c. Do not use content that causes seizures.
- d. Help users navigate and find content.
- 3. Understandable
 - a. Make text readable and understandable.
 - b. Make content appear and operate in predictable ways.
 - c. Users avoid and correct mistakes.
- 4. Robust (not a vegetable)
 - a. Maximize compatibility with current and future user tools ("Future Proofing").
 - i. (Content must be robust enough that it can be interpreted reliably by a wide variety of user agents, including assistive technologies.)
