Safety Committee Charge and Membership	<p>The safety committee reviewed the Charge and Membership. By consensus, no changes were made. Here is the current Charge and membership:</p> <p>Charge: The goal of the Crafton Hills College Safety Committee is to help the San Bernardino Community College District eliminate workplace injuries and illnesses by involving employees in achieving a safe, healthful workplace and by promoting awareness and participation in emergency response programs. The committee:</p> <ul style="list-style-type: none"> • Assists management in identifying safety hazards and suggests ways to eliminate them. • Provides input on planning safety/emergency-related exercises and assists as necessary to carry them out. • Reviews safety-related incidents, injuries, and illnesses and makes suggestions to management for future prevention. • Reviews workplace inspections to identify themes and recommends methods for eliminating or controlling hazards. • Reviews the college’s schedule to update and revise workplace safety and health programs; and makes suggestions to management for safety-related improvements. • Reviews and provides input on safety-related facility plans and projects.

Police to follow up with student.</p> <p>Demian stated we had a huge leaf fall today and ground workers are trying to clear leaves, especially the stairwells.</p> <p>Blake stated parking has been good. A couple of accidents. He reported that some curbing or limit line painting is dull and will add request to fix. Parking permits needed as of today.</p> <p>Just finalized last year's annual security report (2024) and CHC is good. We have had very few incidents that require a Clery report.</p> <p>Ryan had a concern in Lot I from students speeding through the parking lot. He has put up cones to eliminate traffic along the first row next to the training facility.</p>

He will be adding a section to the IPP (Injury or Illness Prevention Program) for employees who work outside when smoke or air quality bad. We will get a monitor to do our own air quality testing. ➤ SWACC property and liability inspection for every property in District is coming. Don't have exact date for CHC in February. Big change this year. They usually come during spring break but this year they will be coming while school is in session but will try to be the least disruptive as possible. <p>Thomas reported:</p> <ul style="list-style-type: none"> ➤ AED/First Aid/Stop the Bleed – if a building has 200 or more and built after 2017, need AED. Any renovation over \$100,00 or more, need AED. We will be adding 3 AEDs. ➤ We purchased 8 cabinets for the Stop the Bleed kits. ➤ Annual safety inspection of labs occurs two times a year.
