#### 4. SB 1440

Troy Dial reported:

- C-ID Descriptors – All of the modifications aside from MUSIC are in CurricUNET. Once the courses are board approved they will be submitted for C-ID approval.

#### 5. Operational Issues

- Troy provided the committee with a report regarding the transfer of activity units at CSU campuses. Crafton has been “over limiting” transfer of activity units in Kinesiology. We have a limit of four units and many CSUs will allow more (and students can transfer those in from another college). Since this is a catalog issue and not part of the course outline of record, Troy will communicate with Kristina/Floyd the changes that need to be made.
- Sherri and Jodi Hanley are working on a plan to develop a Non-Credit Program. Sherri will keep us updated.
