COURSE MODIFICATIONS

A. BUSAD 230 Using Computers for Business

The committee approved BUSAD 230 as a six-year revision. The Distance Education component (100% Online and Hybrid) was also approved.

- NEW DEPARTMENTAL RECOMMENDATION: Successful completion of CIS 091
- NEW CATALOG DESCRIPTION: Introduction to computer and information technology, including the history, terminology, computer hardware and software components, operation of computer systems, networking, ethics, security, examination of information systems and their role in business. Includes an overview and use of selected software including operating systems, word processors, spreadsheets, presentation applications, database management systems, and basic web design and programming. Discussion of the impact of computers in society and the workplace. This course is also offered as CIS 101.
- **NEW SCHEDULE DESCRIPTION:** Introduction to computer and information technology. Examination of information systems and their role in business. Includes an overview and the use of computer software including word

M. RADIOL 216 Mammography

This course provides the Radiologic Technology student the opportunity to gain the necessary knowledge and skills to successfully enter the specialty field of Mammography upon graduation from the Radiologic Technology program at Crafton.

The committee agreed to approve RADIOL 216 as a new course.

Analyzes breast pathology, breast images and positioning.

3. SB 1440

Troy reported:

- The Faculty Development Review Group (FDRG) at the State is reviewing the transfer model curriculum for Business Administration.
- 4. Operational Issues

- It was discussed that the enrollment cap for DE courses was changed from 25 to 35. A question was asked if the cap could be lowered? Kim suggested the following:
 - Check with the ETC Committee to find out why the cap was changed from 25 to 35.
 - What was the process for deciding enrollment caps (all courses and DE)?
- Non-credit courses can now be entered into CurricUNET.
- The State Curriculum Inventory is transitioning from the old system to the Butte State system. The system should be up and running in a couple months. The State will be approving curriculum based on receiving it; this should reduce the bottleneck that we currently experience with the State. We will still have to wait for the course to be assigned a number before it is recognized as an "approved course" and can be offered in the course schedule. With the new system, the liability will rest with the Vice President of Instruction.
- Kristina will give Kim the correct hours/units for RESP 131 and RESP 136.
- Kristina heard back from Anita (Academic Catalog).

Curriculum Module Questions/Answers

- 1. Does it keep a historical tracking of all outlines and is it searchable? Yes, searchable through dashboard.
- 2. Can we have it so the public can have access to viewing the outlines? Read, write with access, read only for public.
- 3. Can it match course objectives from another course outline? Yes
- 4. How many other colleges that use this also use Datatel? Several with Ellucian and Banner
- 5. Can outlines in CurricUNET be uploaded to the new module or will they have to be input by hand? Need to see data extract file sample from Andy.
- 6. What is the cost associated with the product, set-up, and continued use? waiting for sign off from Anne.
- It costs \$10,000 a year for CurricUNET.
- In preparing for R25 (Scheduling Software), the Instruction Office is building course characteristics for each course. In order to keep up with the new courses that are approved, it was suggested that the Schedule/Catalog Data Specialist work with the Faculty Chair/Dean to get the required information.
- It was suggested that Floyd talk to Sherri Wilson about the discrepancies pertaining to MATH 903 Support Lab.
