# 2. COURSE MODIFICATIONS

A. ASL 101 American Sign Language I

The committee approved ASL 101 as a six-year revision.

• NEW CATALOG DESCRIPTION: Introduction to American Sign Language as used by the Deaf community in the United States. Study of a basic vocabulary of approximately 400 signs, typical ASL sentence structures and social conventions involved in ASL. Discussion of the history of d/Deaf education and the Deaf community up to the end of the nineteenth century. NOTE: This course corresponds to the first year of high school American Sign Language.

Note: Currently equated with ASL 109 at SBVC.

B. ASL 102 American Sign Language II

The committee approved ASL 102 as a six-year revision with corrections. The committee recommended changing the departmental recommendation from Concurrent enrollment in ASL 115 to Previous or concurrent enrollment in ASL 115. The prerequisite of ASL 101 was also approved.

- **NEW DEPARTMENTAL RECOMMENDATION:** Eligibility for ENGL 101. Previous or concurrent enrollment in ASL 115
- NEW CATALOG DESCRIPTION: Continuing introduction to American Sign Language as used by the Deaf community in the United States. Study of a more advanced vocabulary of approximately 400 additional signs, ASL sentence structures and social conventions involved in ASL. Discussion of Deaf Culture, norms, and values. NOTE: This course corresponds to the second year of high school American Sign Language.

Note: Currently equated with ASL 110 at SBVC.

C. ASL 103 American Sign Language III

The committee approved ASL 103 as a six-year revision with corrections. The committee recommended changing the departmental recommendation from Concurrent enrollment in ASL 115 to Previous or concurrent enrollment in ASL 115. The prerequisite of ASL 102 was also approved.

• **NEW DEPARTMENTAL RECOMMENDATION:** Eligibility for ENGL 101. Previous or concurrent enrollment in ASL 115

Note: Currently equated with ASL 111 at SBVC.

D. ASL 104 American Sign Language IV

The committee approved ASL 104 as a six-year revision with corrections. The committee recommended changing the departmental recommendation from Concurrent enrollment in ASL 200 or ASL 205 to Previous or concurrent enrollment in ASL 200 or ASL 205. The prerequisite of ASL 103 was also approved.

- **NEW DEPARTMENTAL RECOMMENDATION:** Eligibility for ENGL 101. Previous or concurrent enrollment in ASL 200 or ASL 205
- **NEW CATALOG DESCRIPTION:** Continued intermediate study of American Sign Language as used by the Deaf community in the United States. Study of increasingly more advanced vocabulary and grammar structures and application of skills in both formal and informal contexts.
