### **COURSE MODIFICATIONS**

A. ANTHRO 102 Cultural Anthropology

I. ART 275 Contemporary Sculpture Techniques

J. ASL 102 American Sign Language II

The department is requesting the removal of the following note from the catalog and schedule description. This will help the program qualify for LOTE at the lower level.

- New Catalog Description: Continuing introduction to American Sign Language as used by the Deaf community in the United States. Study of a more advanced vocabulary of approximately 400 additional signs, ASL sentence structures and social conventions involved in ASL. Discussion of Deaf Culture, norms, and values. NOTE: This course may require attendance to Deaf community events.
- **New Schedule Description:** Continuing introduction to American Sign Language as used by the Deaf community in the United States. NOTE: This course may require attendance to Deaf community events.

Fulfills the requirements of Title 22 of the Health and Safety Code for paramedic clinical internship.
- New Schedule Description: Coordination of advanced paramedic training within the hospital setting. Opportunity to direct and engage in emergency care intervention of traumatic and medical emergencies. This portion of the program is primarily conducted in clinical settings in San Bernardino or Riverside county. Fulfills the requirements of Title 22 of the Health and Safety Code for paramedic clinical internship.

N. FIRET 102 Fire Behavior and Combustion

- **New Schedule Description:** Theory and fundamentals of how and why fires start, spread, and are controlled.

O. FIRET 106 Fire Protection Hydraulics and Water Supply

V. PTA 230 Therapeutic Exercise

The Crafton Hills College Physical Therapist Assistant Program must comply with the standards of the Committee on Accreditation in Physical Therapy Education (CAPTE) in order to be accredited, as well as standards specified by the Physical Therapy Board of California for licensure. This course is one in a series of courses leading to a Physical Therapist Assistant Associate of Science Degree.

The committee approved PTA 230 as a new course with a prerequisite of Verified acceptance and enrollment in the Crafton Hills College Physical Therapist Assistant Program and completion of PTA 120 or equivalent. Kim will correct the prerequisite for the limitation of enrollment.

- **Course Title:** Therapeutic Exercises
- Course ID: PTA 230
- **Prerequisite:** Verified acceptance and enrollment in the Crafton Hills College Physical Therapist Assistant Program and Completion of PTA 120 or equivalent
- Corequisite: None
- Departmental Recommendation: None
- Semester Unit: 4
- Minimum Semester Hours: Lecture: 48 Lab: 48
- **Catalog Description:** This course is for second year physical therapist assistant majors. Therapeutic exercise introduces the student to the use of exercise as a preventive and intervention mechanism for pathological conditions which influence strength, endurance and flexibility of the human body. Emphasis is placed upon identification and application of exercise, developmental sequence of exercise, types of exercise, and the use of exercise equipment. Instruction includes the body's physiological response to exercise.
- Schedule Description: Introduction to the use of exercise as a preventive and intervention mechanism for pathological conditions. Emphasis is placed upon identification and application of exercise including the body's physiological response to exercise.

Note: The course is not currently equated with SBVC.

W. PTA 233 Prosthetics and Orthotics for the Allied Health Professional

The committee approved PTA 233 as a new course with a prerequisite of Verified acceptance and enrollment in the Crafton Hills College Physical Therapist Assistant Program and completion of PTA 125 or equivalent. Kim will correct the prerequisite for the limitation of enrollment.

- **Department:** Allied Health Services
- Course Title: Prosthetics and Orthotics for the Allied Health Professional
- Course ID: PTA 233
- **Prerequisite:** Verified acceptance and enrollment in the Crafton Hills College Physical Therapist Assistant Program and Completion of PTA 125 or equivalent
- Corequisite: None
- Departmental Recommendation: None
- Semester Unit: 2

- Minimum Semester Hours: Lecture: 16 Lab: 48
- **Catalog Description:** This course is an introduction to the application of orthotic and prosthetic devices. Included in the course is a discussion and demonstration of the types of devices utilized in the treatment of the disabled individual, as well as procedures commonly used in the maintenance, donning, and removal of these devices. Students will learn how to instruct and prepare the patient to utilize this specialized equipment. Problem solving will be utilized in assisting students to apply standardized practices to meet individual patient needs.
- **Schedule Description:** Introduction to application of orthotic and prosthetic devices. Theory and application along with lab component. Students will be required to problem solve in order to meet patient specific needs.

- Schedule Description: This course will increase the student's knowledge in the anatomy and physiology of the nervous system. Central, peripheral and autonomic system is covered with an emphasis placed on the clinical manifestations of disease or injury as encountered in physical therapy.

Instruction will maintain regular effective contact through conferencing and LMS applications. Instructional materials will be adapted to meet ADA compliance. Instructors will be supported through available campus resources including Alternative Media and Assistive Technology Specialist, DSPS Office, PD Lead, DE Lead, and other available resources to help ensure that instructional materials are accessible to persons with disabilities.

4. Operational Issues:

Keith encouraged everyone to attend the demonstrations coming up for Coursedog and CurricUNET. The first curriculum demonstration will be on November 10. We will also be looking at Smart Catalog and other Curriculum products.

Troy reported that CSU decided that their new Ethnic Studies requirement will be included in general education, and the CSU Chancellor's Office informed CCC Articulation Officers that the COR submission deadline for a new CSUGE Area F will be February 5, 2021. (The deadline for other courses is still in December 2020.) CSU plans to reduce CSUGE Area D, Social Sciences, by three units and require three units in the new Area F. Courses can be listed in both areas but only counted for certification in one. At least for now, CSU is requiring an Ethnic Studies prefix. We might be able to cross-list and propose some courses that are already active and transferable. Troy will contact Brandi, Academic Senate President regarding approval for the prefix and regarding in which discipline the courses will be included.
