COURSE MODIFICATIONS

A. ASL 101 American Sign Language I

The department is requesting to offer an 100% online version of the course not just hybrid.

The committee approved the revision of ASL 101. The Distance Education component was also approved (hybrid and 100% online).

B. EMS 020 Emergency Medical Technician

The department is adjusting the course hours for Field and Clinical time. These hours will be moved to EMS 067.

The committee approved the revision of EMS 020 with a prerequisite of 18 years of age at the time of program orientation and meet the functional job requirements of the Emergency Medical Technician. The corequisites of EMS 021, EMS 022, EMS 023, EMS 025, EMS 066, EMS 067, and EMS 068 were also approved. Kim will correct the units from six to five.

E. EMS 157 Field Externship for the Paramedic

The rationale of "Unit/Hour adjustment based on formula clarification" was incorrect on the agenda. The course is being submitting as a six-year revision and the units/hours will remain the same (12 Units, Field: 576).

• New Schedule Description: Coordination of advanced paramedic training with a field advanced life support unit. Opportunity to direct and engage in emergency intervention in traumatic and medical emergencies. This portion of the program will be on a paramedic unit in San Bernardino or Riverside County. Fulfills the requirements of Title 22 of the Health and Safety Code for paramedic field externship.

L. ENGL 164/ETHS 164 Native American Literature

ENGL 164 Native American Literature

ENGL 164 provides Crafton Hills College students with an opportunity to study the English literature of past and present Native American storytellers. These works include novels, short stories, plays, poems, and song lyrics. This course is associate degree applicable and transfers to CSU.
