## C. CIS 140 Introduction to Networks (Cisco CCNA 1)

The committee approved CIS 140 as a six-year revision. The DE component was also approved (hybrid and 100% online). The emergency remote statement will be added to the course outline.

- New Catalog Description: First in a three-course sequence that qualifies students to take the Cisco Certified Network Associate (CCNA) examinations. Topics include: Local Area and Wide Area Networks (LAN's and WAN's), network devices, the Open System Interconnect (OSI) model, media, cable installation, network design, routing, switching, Network IPv4 & V6 addressing, security, documentation, and basic wireless. Meets latest CCNA certification.
- New Schedule Description: First in a three-course sequence that qualifies students
  to take the Cisco Certified Network Associate (CCNA) examination. Introduction to
  media, cable installation, network design, network IPv4 & v6 addressing, routing,
  switching, addressing, security, documentation, and basic wireless. Meets latest
  CCNA certification requirements.

### D. CIS 141 Routing and Switching Essentials (Cisco CCNA 2)

The committee approved CIS 141 with a prerequisite of CIS 140 as a six-year revision. The DE component was also approved (hybrid and 100% online). The emergency remote statement will be added to the course outline.

- New Course Title: Switching, Routing and Wireless Essentials (Cisco CCNA 2)
- New Catalog Description: Second in a three-course sequence that qualifies students
  to take the newest Cisco CCNA examinations. Topics include: implementing LAN and
  WAN connectivity using routers, switches and wireless access points, IPv4/IPv6
  addressing, network security, access-lists, static and dynamic routing. Students gain
  skills through configuring Cisco devices and managing the software.

 New Schedule Description: Second in a three-course sequence that qualifies students to take the newest Cisco CCNA examinations. Introduction to the operations of Cisco routers, switches and wireless access points in a small network, network security, static and dynamic routing and wireless LAN Technology. Development of skills through configuring Cisco devices and managing the software.

E. CIS 142 Scaling Networks (Cisco CCNA 3)

The committee approved CIS 142 with a prerequisite of CIS 141 as a six-year revision. The DE component was also approved (hybrid and 100% online). The emergency remote statement will be added to the course outline.

- New Course Title: Enterprise Networking, Security and Automation (Cisco CCNA 3)
- New Catalog Description: Third course of a three courses sequence that qualifies students to take the newest Cisco CCNA Certification examinations. In this course students learn how to configure routers and switches for advanced functionality. By the end of this course, students will be able to configure and troubleshoot routers and switches and resolve common issues with OSPF, EIGRP, and STP in both IPv4 and IPv6 networks. Students will also develop the knowledge and skills needed to implement Cisco ACLs and security in a small-to medium sized network as well as troubleshoot Network connectivity issues using network monitoring and management tools.
- New Schedule Description: Third course of a three courses sequence that qualifies students to take the newest Cisco CCNA certification examinations. Students learn how to configure and troubleshoot routers and switches and resolve common issues with OSPF, EIGRP, and STP in both IPv4 and IPv6 networks. Students will also develop the knowledge and skills needed to implement Cisco ACLs and security in a small-to medium sized network, as well troubleshoot network issues using network monitoring and management tools.

#### **NEW COURSES**

F. WFP/N 621, 622, 623 Workforce Preparation Noncredit

The Certified Nursing Assistant (CNA) role is considered an essential critical infrastructure occupation. Employment is expected to increase by 13% between 2019 and 2024, with 1156 open jobs over the five years. The demand before the pandemic was over 200 CNAs per year yet there were 89 awards offered by community colleges from 2017-2020 (Centers of Excellence, October 2020). The pandemic has significantly increased the need for CNAs in the Inland Empire. Students who successfully complete the Nursing Assistant course will be eligible to take the state exam to become certified. Once certified, they are eligible for full-time positions with benefits in long-term care, skilled nursing facilities, home care, assisted living and hospitals.

It was recommended that the courses be taught under Vocational Education. Certificate to follow. Dan will check with Kristina to see if the Course ID numbers will remain the same. Keith is overseeing the Noncredit courses. There was a concern about marketing; we want to make sure students are able to find these courses.

The committee approved VOC/N 621 as a new course. The emergency remote statement will be added to the course outline.

- Catalog Description: This noncredit course focuses on the fundamental principles of basic nursing care necessary to meet the hygiene, comfort, and safety needs of residents. The identification and reporting of resident abuse along with development of skills in communication and interpersonal relations will be discussed. The role of the CNA as part of the health care team and practice of skills to pass the state certification exam are highlighted. The course follows the guidelines established by the California Department of Public Health (CDPH). Successful completion of the course does not ensure certification, which is obtained through the CDPH. Application and related forms are provided at the information session.
- Schedule Description: Fundamental principles of providing basic nursing care to meet hygiene, comfort, and safety needs of residents. Focus on developing effective communication, respecting resident's rights, and preventing and reporting resident abuse. The class follows the guidelines established by the California Department of Public Health (CDPH), Title 22, Chapter 5, Section 2.5.

- Catalog Description: This noncredit course focuses on the application of fundamental principles of basic nursing care necessary to meet the hygiene, comfort, and safety needs of residents in the long-term care environment. The identification and reporting of resident abuse along with development of skills in communication and interpersonal relations will be practiced. The role of the CAN as part of the health care team and practice of skills to pass the state certification exam are highlighted. The course follows the guidelines established by the California Department of Public Health (CDPH). Successful completion of the course does not ensure certification, which is obtained through the CDPH Application and related forms are provided at the information session.
- **Schedule Description:** Clinical application of the basic nursing care required to provide for the hygiene, comfort, and safety needs of clients in long-term health care settings. Focus on roles and responsibilities, knowledge of and adherence to federal and state regulations and demonstration of safe and competent nursing skills and practice in communication.
