COURSE MODIFICATIONS

A. CHEM 151 General Chemistry II

C. MULTI 250 3D Modeling and Animation with Maya II

In order to allow for more different software solutions, the department is requesting a title change.

The committee approved MULTI 250 with a prerequisite of MULTI 150. The Distance Education component was also approved (hybrid and 100% online).

I. Virtual Reality Design Certificate of Achievement

The committee approved the Virtual Reality Design Certificate of Achievement as a new program.

Kristina stated that this program does not need to be state approved because it is under the threshold, but if you want the transcript ID for students and want veterans to be able to use their VA benefits for courses, you have the option to file the program with the state. Iris would need to submit the paperwork to Kristina. Once the course is approved by the State, the title would become a Certificate of Achievement. Iris plans to file this program with the State.
