V. Certified Nursing Assistant Certificate of Completion

The committee approved the Certified Nursing Assistant as a new program. Kim modified the description to remove the courses listed (wrong course numbers), corrected typo in the description from course to program, and punctuation was corrected in the paragraph related to mandatory information session.

# **Certified Nursing Assistant Certificate of Completion**

This noncredit program focuses on the fundamental principles of basic nursing care necessary to meet the hygiene, comfort, and safety needs of residents. The identification and reporting of resident abuse along with development of skills in communication and interpersonal relations will be discussed. The role of the CNA as part of the health care team and practice of skills to pass the state certification exam are highlighted. The course follows the guidelines established by the California Department of Public Health (CDPH). Successful completion of the course does not ensure certification, which is obtained through the CDPH. Application and related forms are provided at the information session.

# Must attend a mandatory information session. Once provisionally accepted, must attend a mandatory orientation, meet all health requirements, and clear background and live scan fingerprinting. Must be 16 years or older. No high school or GED required.
