## IV. Operational Issues

New meeting time in Fall 2025, 1:00 pm – 2:00 pm (2<sup>nd</sup> & 4<sup>th</sup> Monday)

Keith discussed the evidence of progress towards equity goals. Based on student success metrics, the college has improved on equity goals but has not closed equity gaps in 4 out of the 5 metrics identified in the original 2022-2025 equity plan. Delmy is developing action plans. The current equity plan ends in 2025 and the new one starts in fall 2026.

The Respiratory Care bachelor's degree was discussed. There is a new requirement for lower division general education for students in the bachelor's program of 27 units. This reduces the requirements for bachelor students. Processes for awarding bachelor's degrees need to reflect the change. Keith to work with Michael.

ACCJC Standard 3 to be added as a standing item on the agenda this fall.

Non-credit courses are not showing content, Kim is working on having this fixed.

Phase II, Part B of the Common Course Numbering is in the final revision.
