3. PDC Charges/membership review	<ul style="list-style-type: none"> - Crafton Council recommended the removal of the word “minimum” from the committee membership. Committee members understood the recommendation but were confused on the opposition around the word “minimum.” Proposed/counter of wording to read “A minimum of 8 faculty as determined by the Academic Senate...” - It is proposed that we reword the membership to read, “2 classified senate appointed and 2 CSEA appointed members (totallying 4 classified)” PDC voted and motion approved. 	Ketih: Bring wording back to Academic Senate and Crafton Council.
