Directors would like to know which events are important to attend as a Director and which are just encouraged.</li> <li>New Promise videos of individual students are being produced and shared on social media to promote the Promise program.</li> <li>Account Clerk Vacancy</li> <li>Mike, Michelle and Ray (auditor) have met with various accounting firms to determine the possibility of outsourcing the accounting function of the department. Christine is willing to help on a regular basis.</li> <li>Outsourced tasks to include: reconciliation, sales receipts, Quickbooks updates, reports, etc.</li> <li>In-House tasks to include: deposits, check requests, thank you letters, scanning, etc.</li> </ul>	Michelle to present events and encourage Directors to attend. Reports	<ul> <li>Review P&amp;L and Balance Sheet</li> <li>\$187,840.14 - Current balance in checking account. Committee would like to bring the balance down to \$150k and put the overage in our investments. Current balance is actually closer to \$137k, so no need to move funds at this time.</li> <li>We are in the process of finalizing the close-out of the Community Bank account (\$27.58).</li> <li>Investments have increased since last month's report from \$2.4m to \$2.5m.</li> <li>P&amp;L Report - Christine is working on cleaning up errors and will discuss with auditor (Ray Ashworth)</li> <li>Ray to begin working on 18-19 audit.</li> </ul>		

	<ul> <li>Art Plan – we have been depreciating the art by 10-15% each year, but would like to expedite the process to get art off the books sooner. Will need support of Foundation Board to authorize a larger percentage to write off, but so that it does not negatively affect impact of receiving future grants.</li> </ul>	Michelle to add art discussion to Full Board agenda.
	<ul> <li>Crafton Hills College, Kevin Horan</li> <li>SBCCD is operating in a deficit.</li> <li>Fall Enrollment at Crafton is up 8%</li> <li>Promise Program is up and running – local high schools are starting to promote more to students. Currently being funded by FCC auction funding.</li> <li>50<sup>th</sup> Anniversary Endowment Challenge – to raise \$1million by 2022. Kevin has 100% management participation and now looking for support from Faculty and Classified.</li> <li>Kevin has also been meeting individually with every Foundation Director, only a few more left to meet with.</li> </ul>	
	<ul> <li>Resource Development, Michelle Riggs</li> <li>Investement Committee meeting will be on Friday, Merrill Lynch will be reporting on investments.</li> <li>Development Committee has met once. Currently reviewing proposals from consultants. Kevin and Michelle to make final decision and committee will move forward.</li> <li>Gala theme to be Olympics. Committee meeting again 10/18/19.</li> <li>Grants: Recently submitted – 2 for Edison and 1 for Wells Fargo. In Process - Molly Adams and Osher</li> <li>Donor/Scholar Reception – may change format and combine into one event in the Spring.</li> <li>Scholarships – With the Promise Program paying for students' expenses, there has historically been \$4000 offered for incoming high school students from local feeder high schools that could be re-allocated.</li> <li>San Manuel – final report due next week. Valley just submitted their grant proposal, so Crafton will submit one as well and request funding to support the Promise Program.</li> </ul>	Michelle to discuss high school scholarship funds to be re- allocated for other students, i.e. "Re-Entry" with scholarship committee.
