Chapter 5 – Student Services

AP 5052 OPEN ENROLLMENT

NOTE: *The language in red ink is legally advised. Local practice may be inserted, but should reflect the following.*

All courses of the District shall be open to enrollment in accordance with ~~insert reference to specific board policy or resolution~~ BP 5052 and a priority system consistent with AP 5055 titled Enrollment Priorities. Enrollment may be limited to students meeting properly validated prerequisites and co-requisites, or due to other non-evaluative, practical considerations as determined by the ~~designate~~ college.

No student is required to confer or consult with or required to receive permission to enroll in any class offered by the District, except as provided for in AP 5055 titled Enrollment Priorities and ~~list District programs that permit restricted enrollment, e.g. vocational or allied health programs.~~ designated college programs as delineated in the respective college catalog.

Students are not required to participate in any pre-registration activities not uniformly required, and no registration procedures are used that result in restricting enrollment to a specialized clientele, except as provided for in AP 5055 titled Enrollment Priorities and ~~list District programs that permit restricted enrollment, e.g. career/technical or allied health programs.~~ designated college programs as delineated in the respective college catalog.

A student may challenge an enrollment limitation on any of the following grounds:

- The limitation is unlawfully discriminatory or is being applied in an unlawfully discriminatory manner;
- The District is not following its enrollment procedures;
- The basis for the limitation does not in fact exist.

Students may challenge an enrollment limitation by following the adopted petition process at the local college.

66 (a) The governing board of a community college district shall adopt by resolution the following or a
67 comparable statement: "The policy of this district is that, unless specifically exempted by statute or
68 regulation, every course, course section, or class, reported for state aid, wherever offered and
69 maintained by the district, shall be fully open to enrollment and participation by any person who has
70 been admitted to the college(s) and who meets such prerequisites as may be established pursuant
71 to section 55003 of of division 6 of title 5 of the California Code of Regulations."

73 (b) The statement of policy adopted by the board pursuant to subdivision (a) shall be published in the
74 official catalog, schedule of classes, and addenda to the schedule of classes for which full-time
75 equivalent student (FTES) is reported for state apportionment. A copy of the statement shall also be
76 filed with the Chancellor.

90  **§ 58106. Limitations on Enrollment.**

91

92 In order to be claimed for purposes of state apportionment, all courses shall be open to enrollment by
93 any student who has been admitted to the college, provided that enrollment in specific courses or
94 programs may be limited as follows:

95

96 (a) Enrollment may be limited to students meeting prerequisites and corequisites established pursuant
97 to section 55003,

98

99 (b) Enrollment may be limited due to health and safety considerations, facility limitations, faculty
100 workload, the availability of qualified instructors, funding limitations, the constraints of regional
101 planning or legal requirements imposed by statutes, regulations, or contracts. The governing board
102 shall adopt policies identifying any such limitations and requiring fair and equitable procedures for
103 determining who may enroll in affected courses or programs. Such procedures shall be consistent with
104 one or more of the following approaches:

105
106 (1) limiting enrollment to a "first-come, first-served" basis or using other nonevaluative selection
107 techniques to determine who may enroll; or

108
109 (2) limiting enrollment using a registration procedure authorized by section 58108; or

110
111 (3) in the case of intercollegiate competition, honors courses, or public performance courses,
112 allocating available seats to those students judged most qualified; or

113
114 (4) limiting enrollment in one or more sections of a course to a cohort of students enrolled in one or
115 more other courses, provided however, that a reasonable percentage of all sections of the course do
116 not have such restrictions; or

117
118 (5) limiting enrollment using any selection procedure expressly authorized by statute; or

120 (6) with respect to students on probation or subject to dismissal, the governing board may, consistent
121 with the provisions of sections 55031 and 55032, limit enrollment to a total number of units or to
122 selected courses, or require students to follow a prescribed educational plan.

123
124 (c) A student may challenge an enrollment limitation established pursuant to subdivision (b) on any of
125 the following grounds:

126
127 (1) the enrollment limitation is either unlawfully discriminatory or is being applied in an unlawfully
128 discriminatory manner;

129
130 (2) the district is not following its policy on enrollment limitations;

131
132 (3) the basis upon which the district has established an enrollment limitation does not in fact exist; or

133
134 (4) any other criteria established by the district.

135
136 (d) The student shall bear the burden of showing that grounds exists for the challenge. Challenges
137 shall be handled in a timely manner, and if the challenge is upheld, the district shall waive the
138 enrollment limitation with respect to that student.

139
140 (e) In the case of a challenge under subdivision (c)(1), the district shall, upon completion of the
141 challenge procedure, advise the student that he or she may file a formal complaint of unlawful
142 discrimination pursuant to subchapter 5 (commencing with section 59300) of chapter 10. Completion
143 of the challenge procedure shall be deemed to be an effort at informal resolution of the complaint
144 under section 59327.

Procedures for registration and standards for enrollment in any course shall be only those which are consistent with these and other sections of Title 5 and uniformly administered by appropriately authorized employees of the district.

Except as otherwise provided by state law, no student shall be required to confer or consult with or be required to receive permission to enroll in any class from any person other than those employed by the college in the district.

Students will not be required to participate in any preregistration activity not uniformly required; nor shall the college or district allow anyone to place or enforce nonacademic requisites as barriers to enrollment in or the successful completion of a class.

No registration procedures shall be used that result in restricting enrollment to a specialized clientele.

The following registration procedures are permissible: special registration assistance to the handicapped or disadvantaged student as defined by statute, for the purpose of providing equalization of educational opportunity; and enrollment of students in accordance with a priority system established pursuant to legal authority by the local board of trustees.

With respect to accessibility to off-campus sites and facilities, no student is to be required to make any special effort not required of all students to register in any class or course section. Once enrolled in the class, all students must have equal access to the site.
