- Focus on Transfer Promote, expedite & value
  - Aligns with CHC Mission & Ed Master Plan
  - Title 5 Regulations [Section 51027]
    - "... designate a particular location on campus that is readily identifiable and accessible to students, faculty, and staff as the **focal point** of transfer functions."
  - Transfer Culture
  - Opportunities

# Activity I – Strengthening Transfer and Success of Hispanic Students

- Transfer Center
- Transfer Advocacy Program
- Mobile Transfer Center
- Expanded Honors Program
- Additional full-time Counselor/Transfer Coordinator
- Reduces the burden on the general fund by funding two positions for five years

## Today 2011

- Create more H Course Outlines
- Develop more articulation agreements
- Sign up more students in the Honors Program
- Establish a space for honors students to use—Honors Lounge

### Program Requirements

#### FOR ADMISSION

- GPA of 3.0 or higher
- Eligibility of English 101 and a transfer level math
- Submit an application to the CHI director

#### FOR COMPLETION

- 15 semester units of honors courses
- GPA of 3.25 or higher
- Community service
- Completion of AA or transfer requirements



#### How it works

- 5 seats regular classes reserved for H students
- Honors students must meet requirements of H Course Outline
- Students can take advantage of the HTCC agreements CHC and 18 different 4-year institutions

#### Sophomore Experience Program

Includes a series of interventions that have proven successful elsewhere for combating the "sophomore slump":

- Sophomore seminar to help 2<sup>nd</sup> -year students confirm a major and explore careers
- Co-curricular programming, such as "Major Week"
- Peer-networking and peer-bonding experiences for sophomores, such as "Sophomore Quest"

## Sophomore Experience, cont'd

Builds on First-Year Experience (FYE)

First step = develop FYE more fully

- SOAR<sup>3</sup> program
- Online Orientation package
- Welcome to Crafton Night
- Parent Orientation
- PASSport

# Supplement Instruction (SI)

- An academic assistance program
- Peer-facilitated study sessions
- Targets "high-risk" courses, rather than at-risk students
- Recruitment process, for both students and faculty, will begin in Spring 2011 Semester.
- SI sessions will begin in Fall 2011.
