1. Approval of minutes from September 27, 2010 meeting

2. Action Items

**COURSE MODIFICATIONS**

- A. CIS 091 College Keyboarding and File Management

Kim Salt will remove the Distance Education (DE) Addendum from the course outline. At this time, the department is not requesting DE approval.

The committee agreed to approve CIS 091 as a six-year revision.

- B. CIS 117 Scripting

The committee agreed to approve CIS 117 as a six-year revision.

- **NEW CATALOG DESCRIPTION:**

Introduction to Web page scripting and programming using current scripting languages. Includes program development, debugging, and implementation of programs to enhance web pages. Course topics include: Client-side and Server-side scripts, ASP and database integration. This course applies to the Associate of Science Degree as well as to the Certificate requirements in Computer Information Systems.

C. CIS 161 Web Site Design and Programming Using Dreamweaver

The committee is recommending the last sentence under Goals for the Course “This course is appropriate to the college mission in that it is part of a complete vocational education programming leading to employment” be revised to reflect the current college mission statement or be deleted.

The committee agreed to approve CIS 161 as a six-year revision with the condition that the last sentence be revised to reflect the current college mission statement or be deleted.

- **NEW COURSE TITLE:** Website Design and Programming Using Dreamweaver
- **CATALOG DESCRIPTION:** In-depth study of Website design and programming using Dreamweaver. Students will design, create, publish and maintain Websites using Dreamweaver.
- **SCHEDULE DESCRIPTION:** In-depth study of Website design and programming using Dreamweaver. Students will design, create, publish and maintain Websites using Dreamweaver.

D. CIS 163 Introduction to PhotoShop

### 4. Miscellaneous

#### A. Bill: SB 1440

The committee briefly discussed SB 1440 recently signed into law that requires community colleges develop and grant associate degrees for transfer commencing with the Fall term of the 2011– 2012 academic year. Once the details have been worked out, we will begin to revise the degrees to comply with the new requirements. Given the short timeline for implementation, the degrees will have to be fast-tracked through the CurricUNET process. Ben Mudgett stated that Web Advisor will be updated by April 1, 2011. The degrees will have to be resubmitted to the State Chancellor's Office for approval. Once the degrees are in place, there will be more clarity and consistency about the lower division preparation and students will be guaranteed a place in the CSU.

For students not wishing to transfer we may want to keep some of the degrees in the area of Career and Technical Education.
