ENROLLMENT INFORMATION
2024-2025 Academic Year

Thank you for your interest in the Crafton Hills College Child Development Center/Lab School. The Center offers several programs for children 3-5 years of age:

- A part-day private pay early education program, 8 am – noon.
- A full-day extended care program 7 am – 4:30 pm for enrolled private-pay early education participants only.
- A State Preschool program which is income qualifying and subsidized by the San Bernardino County Superintendent of Schools. This is a Monday – Friday, 3-hour per day program 8:15-11:15 or 12:30-3:30.

Please read the following information carefully before completing the application:

The Eligibility Form (SPS) & the Interest Form are **NOT** a guarantee of enrollment; they are an initial eligibility/waiting list application only. Parents will be notified by phone or email if and when the child is accepted for enrollment (look below). Applicants who are accepted will be notified as soon as possible prior to the start of school. If a child is not initially accepted, the application will remain active for the current academic year and notification will be made as space becomes available. **It is each parent's responsibility to notify the Center at (909) 389-3401 of any changes involving telephone numbers, income, schedule changes, etc. It is also each parent's responsibility to RESUBMIT a new application each May 6th for the upcoming academic year.**

ELIGIBILITY:

Early Education/Preschool Program (Private Pay): Children of students, college staff and faculty, and all members of the community are eligible for enrollment. Children must be 3 years of age by December 1st of the current school year for which they are enrolling.

State Preschool (State Subsidized): Family's full monthly gross income must be entered onto the application and income must meet CDE guidelines. First priority goes to Child Protective Service and agency referrals for 3 & 4 year olds as well as to 3 & 4 year old children who are on Individualized Education Plans. The next priority will be given to 3 & 4 year old children based on income and ranking provided by current CDE guidelines. Children that will be 3 years of age by December 1st of the current school year for which they are enrolling may enroll to begin in August. Children with a 3rd birthday that occurs on or after December 2nd can begin on or after their 3rd birthday.

APPLICATION PROCEDURE:

1. Complete the appropriate Form for the program you are applying for – **Child Development Center Preschool/Child Care Interest Form** or **State Preschool Eligibility Form**. Make sure to carefully and accurately complete every item. Forms submitted with missing information will **NOT** be processed.
2. Forms will be accepted starting **May 6th for the 2024-2025 academic year**. Forms will be accepted on an on-going basis throughout the academic year. Return the completed form to the Child Development Center. **This form is for the 2024-2025 academic year only.**
3. Registration will begin in May for the 2024-2025 school year. You will be notified by telephone or email. You will be asked to complete a registration packet, schedule an appointment to complete the registration process, and attend a mandatory orientation session. Also, at this time, **Private-Pay Program** applicants **only** will be required to submit a **non-refundable registration fee and materials fee**, payable by check or money order. You are welcome to call the Center at any time to check on the status of your application.
